- 3.0 INTEGRITY PACT: Integrity Pact is required for package with estimated cost of Rs.1(one) crore or above only (i.e for Package- A & B). The bidder shall have to submit an Integrity Pact (in 02 copies) on non-judicial stamp paper of Rs.100/- as per pro-forma enclosed with Tender Form. One copy shall be retained by BIHARGRID and the other copy shall be returned to the bidder duly signed by BIHARGRID representative.

- e) All the pages of the integrity pact are to be signed by the Bidder. If the Bidder is a partnership or a consortium, the Integrity Pact shall be signed by all the partners or consortium members.
- f) Bidders are required to clearly indicate the name and designation of the signatory(ies) as well as the name and address of the witnesses.
- g) The Bidder shall not change the contents of the Integrity Pact.
- h) Bidder may note that Bidder's failure to submit the Integrity Pact duly signed alongwith the Bid shall lead to outright rejection of the Bid.
- 4.0 Each package shall be evaluated and awarded independently. However, BIHARGRID reserves the right to award more than one package to one bidder, if they have financial, technical & working capacity etc.
- 4.3 Notwithstanding anything stated above, BIHARGRID reserves the right to assess the bidder's capability and capacity to perform the contract, should the circumstances warrant such assessment necessary in its overall interest. Bidder may have to produce originals of documents submitted to qualify against the package, which shall be returned after verification & shall not be retained by BIHARGRID.
